REGULATIONS of the PROMOTION 'Autumn Promotion' (hereinafter referred to as 'Regulations').

Preamble

This Promotion is dedicated to stylists - both those who run beauty parlours, as well as those who perform nail styling services as employees of beauty parlours or ambulant.

By organising this Promotion, the Organiser wishes to support smaller entrepreneurs who provide nail styling services with INDIGO NAILS products, both those who run beauty parlours, as well as those who perform nail styling as employees of beauty parlours or ambulant persons.

Under no circumstances <u>is the Promotion intended for entrepreneurs</u> <u>selling cosmetic products</u>, <u>including INDIGO NAILS brand products</u>, <u>as part of their business activity (distributors, sub-distributors, wholesalers).</u>

The Promotion is not aimed at entities professionally involved in the sale of cosmetic products, including products of the INDIGO NAILS brand, participating in the Promotion, purchasing products at lower promotional prices, and then selling the products obtained at the lower price at an even higher profit for their sales activity. Such actions are strongly objected to by the Organiser, and persons who participate in the Promotion even though they do not fulfil the terms and conditions of participation will be subject to prosecution,

that do not meet the conditions of participation shall be subject to consequences.

1. Organiser and Duration of the Promo0on

- 2. The Organiser of the Promotion 'Autumn Promotion' (hereinafter: 'Promotion') via:
 - 1. the online shop https://www.indigo-nails.com/eu-de/, (hereinafter: Organiser 1);
 - the online shop https://www.indigo-nails.co.uk is UNITED BEAUTY LIMITED a company incorporated under the laws of the United Kingdom, registered at Companies House under the number 12076727, VAT: GB332687684, with its registered office at: 20-22 Wenlock Road, London, England, N1 7GU (hereinafter: Organiser 2);
 - 3. the online shop https://www.indigo-nails.es/ is INDIGO NAILS ESPANA SL, a company incorporated under Spanish law, registered in the Registradores de Espana, in the BARCELONA Registry, under NIF number: B10731271, with its registered office at: Calle Gelabert 38, mezzanine 1², 08029 Barcelona. (hereinafter: Organiser 3);
 - 4. Indigo Nails stationary salon in Łódź at Senatorska Street 14/16, 93-192 and online shop https://www.indigo-nails.com/ is Indigo Nails Sp. z o.o. with the registered office in Łódź at Senatorska Street 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Economic

Division of the National Court Register under KRS number: 0001099337, holding NIP: 7292755541 and REGON 528319750 (hereinafter: Organizer 4).

- 3. The Promotion may also be organised by distributors of the INDIGO NAILS brand, who have joined it.
- 4. The Promotion shall run from 02.10.2024 at 00:01 (CET) until 22.11.2024 at 23:59 (CET) or until the stocks are exhausted or the Promotion is cancelled by the Organiser (hereinafter: Promotion Duration).
- 5. The Promotion may also be organised by the distributors themselves in the stationary shops and online shops they run this is a voluntary participation.

1. General provisions

- 1. The Promotion shall take place in accordance with these Terms and Conditions.
- 2. Before entering the Promotion, the Participant shall read the Terms and Conditions, in particular the terms and conditions of participation in the Promotion.
- 3. By entering the Promo0on, the Par0cipant confirms that he/she has read the Terms and Condi0ons, understands the Terms and Condi0ons and accepts all rules of the Promo0on included in the Terms and Condi0ons.

1. Participation in the Promo0on

- 1. The ParOcipant in the PromoOon shall be a consumer, i.e. a natural person making a legal act under the terms of these Terms and CondiOons not directly related to their business or professional ac=vity, as well as an entrepreneur running a business or professional activity on their own behalf, subject to parOcipaOon 2.
- 2. The Promotion shall not be open to distributors and sub-distributors of nail styling products, wholesalers and persons who display products in marketplaces this shall also apply to persons who perform a representative function in the aforementioned entities, as well as partners in the aforementioned entities. The exclusion shall not apply to entities which do not sell cosmetic products on a professional basis, and sell individually or occasionally, to which the ParOcipant, by accepting the Terms and CondiOons and parOcipaOng in the PromoOon, agrees.
- 3. In the event that any of the persons listed in Subparagraph 2 participate in the Promotion, or in the event that the Participant allocates the products purchased in the Promotion for sale, the Organiser shall have the right:
 - 1. If there has been no surrender of the object of the sales agreement entered into during the Promotion to withdraw from the sales agreement (within 2 months of entering into it) and not to surrender the object of the sales agreement, or to demand the difference between the price of the products not included in the Promotion and the price for which the Participant purchased the products under the Promotion conditioning the surrender of the object of sales on payment of the difference depending on the decision of the Organiser;
 - 2. If the subject of the sales agreement entered into during the Promo0on has been handed over withdraw from the sales agreement (within 2 months from entering into it) and demand the return of the subject of sale or demand the difference

between the price of the products not included in the Promo0on and the price for which the ParOcipant purchased the products within the Promo0on - depending on the decision of the Organiser.

4. In addition, in each of the cases described in Subparagraph 3, the Organiser may claim from the Participant reimbursement of the logistic costs connected with processing the order covered by the Promotion in the amount of EUR 3.20 per each item constituting the order.

1. Terms and Conditions of the Promo0on

- 1. The Participant takes part in the Promotion by placing an order in the Organiser's online shop during the Promotion period.
- 2. The Promotion shall apply to orders placed during the Promotion period without territorial restrictions, subject to the territorial delivery conditions applicable to the Organiser.
- 3. The purpose of the Promotion is to grant Participants the promotion in the form of a complimentary cream, i.e. Pumpkin Latte hand cream 30ml not for sale for orders:
 - 1. placed with Organiser No. 1 DE: over €60 the product will be added to the order, as a freebie;
 - 2. placed with Product Promoter 2 UK: over £50 the product will be added to your order as a free gift;
 - 3. from Promoter no. 3 ES: €60 the product will be added to your order as a free gift;
 - 4. placed with Organiser No. 4 EN: 250.00 the product will be added to the order, as a freebie.
- 4. One complimentary item is designated for each amount spent, so if the amount is two, three, four times etc., this is the number of items the Participant will receive as a complimentary item to the order.
- 5. The promotions referred to in paragraph 3 above are cumulative.
- 6. Once the products have been added to the basket, a free product/products will also be included in the order depending on the nominal amount of the order.
- 7. Joining the Promotion is voluntary.
- 8. During the Promotion, each Participant may place any number of orders.
- 9. A Participant in the Promotion may receive more than one complimentary item during a single purchase.
- 10. The Customer may refuse the freebie due to lack of interest in the subject matter.

1. Withdrawal from the sales contract

In the event that the provisions of generally applicable law grant the Participant the right to withdraw from the sales contract and return the products, the return of the products purchased in the Promotion is possible insofar as it constitutes a whole set of new and unused items purchased in the Promotion.

1. Complaints

- 1. Any complaints regarding the way in which the Promotion is conducted should be submitted by Participants by email to: reklamacje@indigo-nails.com, customerservice@indigo-nails.co.uk, quejas@indigo-nails.es.
- 2. The complaint should include the note: 'Autumn Promotion'.
- 3. Complaints may be submitted throughout the entire duration of the Promotion, and also up to 14 days from the date of delivery of products being the subject of a sales agreement concluded as part of the Promotion.
- 4. The complaint should contain the following data of the person making the complaint: first name, surname and exact address, as well as the exact description and reason for the complaint and the claim of the person making the complaint.
- 5. Complaints lodged after the deadline or not containing the information referred to in Clause 5 shall not be examined.
- 6. Complaints shall be considered immediately, however no later than within 30 days of their receipt by the Organiser.
- 7. In the event of withdrawal from the Sales Agreement or return of the goods in the online shop, the Participant is obliged to return also the free of charge goods in an intact state.

1. Protection of personal data

- 1. The Administrator of the personal data of the ParOcipants in the Promo0on shall be the Organiser from whom the ParOcipant purchased products under the Promo0on.
- 2. The personal data collected in connection with the Promotion shall be processed for the purpose of performance of the Sales Agreement, for accounting purposes, and also for the purpose of pursuing claims and defending against claims arising from the Sales Agreement based on the Administrator's legitimate legal interest in pursuing claims and defending against claims.
- 3. The Participants' personal data may be disclosed to entities supporting the Organiser in the implementation of the Promotion, including in particular marketing agencies, courier companies, the Postal Operator, a law firm, an accounting office.
- 4. In connection with the Organiser's processing of personal data, Participants shall have the following rights:
 - 1. the right of access to the data and the right to request rectification, erasure or restriction of its processing;
 - 2. The right to transfer the personal data provided to another controller;
 - 3. The right to object to the processing of the data.
- 5. Participants also have the right to lodge a complaint with the competent supervisory authority.
- 6. The personal data of Participants in the Promotion shall be stored for the period during which it is possible to make a complaint, and in the case of a complaint for the time necessary to consider the complaint, until the statute of limitations for claims.
- 7. Providing personal data is voluntary, however, it is a necessary condition for the performance of the sales agreement. The consequence of not providing personal data will therefore be that the sales contract cannot be fulfilled.

- 8. Personal data will not be subject to profiling.
- 9. Personal data will not be transferred outside the EEA.

1. Final provisions

- 1. These Terms and Conditions are available throughout the duration of the Promotion at https://www.indigo-nails.com/.
- 2. The Terms and Conditions come into force on the date the Promotion starts.
- 3. During the period of the Promotion, lead times may be extended.
- 4. By participating in the Promo0on, the Par0cipant accepts the rules set out in these Terms and Condi0ons and declares that he/she has familiarised himself/herself with the rules set out in these Terms and Condi0ons and does not raise any objections in this respect.
- 5. The Organiser reserves the right to change these Terms and Condi0ons during the period of the Promo0on, without giving any reason, with the proviso that the rights acquired by the ParOcipants before the change shall be respected. In particular, the Organiser reserves the right to shorten the duration of the Promo0on or to exclude individual items from the Promo0on as a result of running out of stock. The Organiser may make such a decision separately.
