

**RULES OF PROCEDURE OF THE COMPETITION** ‘Create a prediction for 2025’. (hereinafter ‘Regulations’).

*This Competition is dedicated to the customers of the brands created by the Organisers, as well as stylists and fashionistas.*

*By organising this Competition, the Organisers want to find out the favourite autumn colours of people associated with the brands and products created by the Organisers. A wider insight into the tastes of those taking part in the Competition will contribute to a better understanding of the needs of the Organisers’ customers and may influence the creation of products related to the autumn colour habits of the Competition Organisers’ customers.*

*Under no circumstances is the Competition intended for entrepreneurs selling the Organisers’ products as part of their business (distributors, sub-distributors, wholesalers, drugstores, online shops, entrepreneurs displaying products in market places).*

#### **1. Organiser and duration of the Competition**

1. The co-organisers of the Competition ‘Create a prediction for 2025’ (hereinafter:

‘Competition’) are:

1. INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Łódź, ul. Senatorska 14/16, 93-192 Łódź, entered in the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Economic Division of the National Court Register under KRS number: 0001099337, holding NIP: 7292755541 and REGON: 52831975000000 (hereinafter: INDIGO NAILS) and,
2. Anna Nabiałek conducting business activity under the firm MARSALA Anna Nabiałek with registered office in Częstochowa, address: 100 Legionów Street, 42-200 Częstochowa, registered in the Central Register and Information on Business Activity, maintained by the Minister of Development and Technology, NIP: 9492116025, REGON: 362711605 (hereinafter: MARSALA) (hereinafter: Organisers).

1. **The Competition will run from 9 October 2024 from 10:00 a.m. (GMT +2 Central European Time) to 13 October 2024 until 23:59 p.m. (GMT +2 Central European Time) and the results of the Competition will be announced by the Organisers on 16 October 2024. (hereinafter: duration of the Competition).**

#### **1. General provisions**

1. The Competition will be held in accordance with these Terms and Conditions.
2. Before entering the Competition, the Participant should read the Regulations, in particular the terms and conditions of participation in the Competition.
3. By entering the Competition, the Entrant confirms that he/she has read the Terms and Conditions, understands its provisions and accepts all the rules of the Competition contained in the Terms and Conditions.

## **1. Participation in the Competition**

- 1. The Competition is open to consumers, i.e. natural persons making a legal action under the terms of these Terms and Conditions, not directly connected with their business or professional activity, as well as entrepreneurs, i.e. natural persons, legal persons and organisational units referred to in art. 33(1) § 1 of the Polish Civil Code, conducting their own business or professional activity, subject to the provisions of paragraph 2.**
- 2. The Entrant must belong to the circle of INDIGO NAILS and MARSALA observers on the Instagram and Facebook platforms - both at the time of taking part in the Contest and at the time of selecting the winner.**
- 3. The Competition is not open to distributors, sub-distributors of the Organiser, wholesalers, drugstores, online shops, or persons who display products in the market place - this also applies to persons who have a representative function in the aforementioned entities, as well as the partners of the aforementioned entities. This exclusion does not apply to persons who are not professionally involved in the sale of cosmetic or clothing products and who sell only on an individual or occasional basis.**
- 4. In the event that any of the persons referred to in point 3 take part in the Competition, the Organisers shall have the right:**
  1. If there has been no shipment of a prize in the Contest - to change the selection of the winner and send the prize to another selected eligible Participant - in the event of the above-mentioned case, the vacant place shall be taken by the Participant ranked directly behind the disqualified Participant,
  2. If there has been a shipment of the Prize in the Contest - to demand the return of the Prize in kind in an undamaged condition (undamaged and originally packaged products, including unopened products) or to demand the return of the value of the Prize - depending on the decision of each of the Organizers.

**In addition, in any of these cases, the Organizers may claim from the Participant a reimbursement of logistical costs (verification of eligibility to participate in the Contest, proceeding with the dispatch of the Prize) related to the dispatch of the Prize in the Contest in the amount of 50 PLN.**

## **1. Terms and Conditions of the Competition**

1. The Competition is run on each Organiser's profile on Instagram and Facebook.
2. The Competition begins when the Organisers post a Competition post asking 'Indicate your zodiac sign and create and describe for yourself a prediction for 2025! Answer with creative reasoning.'
3. Participant takes part in the Contest by posting an answer to the contest question under the contest post.
4. A Participant can add one comment on one platform. However, on the Facebook platform, an Entrant can add a comment under both the Indigo brand and Marsala brand post.
5. The organisers will select 3 persons who will provide the most interesting answers and indicate which person has obtained which place.
6. The results of the Competition will be announced on Instagram and Facebook on each Organiser's profile in the form of Instastories, by tagging the winner.
7. The Contest is open to 1st, 2nd and 3rd places, with the following prizes provided by the Organisers for each place:
  1. Place I: a voucher to use for shopping in Indigo worth 400,00 PLN + a T-shirt with the selected zodiac sign + a voucher to Marsala worth 300 PLN;
  2. Place II: a voucher to be used for shopping in Indigo of the value of 300,00 zł + T-shirt with the chosen zodiac sign + 200 zł voucher to Marsala.
  3. Place III: a voucher to be used for shopping in Indigo worth 200,00 zł + T-shirt with the selected zodiac sign + a voucher to Marsala worth 100 zł.

8. The prize cannot be exchanged.
9. The prize can be renounced.
10. Within 7 days from the date of posting on Instagram and Facebook the post with the results of the Contest, representatives of the Organisers shall contact the winners in a private message in order to obtain their correspondence address to which they will send the Prize for taking the relevant place.
11. The prizes will be dispatched within 7 days of receipt of the winners' mailing address by the Organisers' representatives.

#### **1. Personal data protection**

1. **The Administrator of the personal data of the Contest Entrants is the Organisers.**
2. **Personal data collected in connection with the Competition will be processed for the purpose of prize shipment, for accounting purposes, as well as for the purpose of pursuing claims and defending against claims arising from the Competition - based on the Administrator's legitimate legal interest in pursuing claims and defending against claims.**
3. **Participants' personal data may be disclosed to entities supporting the Organisers in the execution of the Competition, including in particular marketing agencies, courier companies, the Polish Post Office, a law firm, an accounting office.**
4. **In connection with the processing of personal data by the Organisers, Participants have the following rights:**
  1. the right of access to the data and the right to request rectification, erasure or restriction of its processing;
  2. The right to transfer the personal data provided to another controller;
  3. The right to object to the processing of the data.
1. **Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.**
2. **The personal data of the Contest Participants will be stored for the time necessary to fulfil the obligations imposed by the Organisers in connection with the organisation of the Contest.**
3. **Providing personal data is voluntary, however, it is a necessary condition for the dispatch of obtained prizes. Therefore, the consequence of not providing personal data will be the impossibility of prize shipment.**

2. **The Rules of Procedure shall enter into force on the date of commencement of the Contest.**
