

REGULATIONS of the PROMOTION "30% on Pedicure Base" (hereinafter: "Regulations").

Preamble

This Promotion is dedicated to stylists - both those who run beauty salons, as well as those who perform nail styling as employees of beauty salons or ambidextrous.

By organizing this Promotion, the Organizer wants to support smaller entrepreneurs who provide nail styling services on INDIGO NAILS products, both those who run beauty salons, as well as those who perform nail styling as employees of beauty salons or ambulant.

The purpose of the Promotion is not for entities professionally engaged in the sale of cosmetic products, including INDIGO NAILS brand products, to participate in the Promotion, buy products at lower, promotional prices, and then sell the products obtained at the lower price at an even higher profit for their sales activities. Such actions are firmly opposed by the Organizer, and consequences will be drawn against those who participate in the Promotion despite not meeting the conditions of participation.

1. Organizer and duration of the Promotion

1. The organizer of the Promotion "30% on Pedicure Base" (hereinafter referred to as the "Promotion") is through the online store <https://www.indigo-nails.com/>, as well as stationary in the Showroom at Senatorska 14/16, 93-192 Lodz, is INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Lodz, at ul. Senatorska 14/16, 93-192 Łódź, entered in the Register of Entrepreneurs by the District Court for Łódź-Centre in Łódź, XX Business Division of the National Court Register under KRS no.: 0000919132, holding NIP: 7272792881 and REGON: 101805889, share capital: PLN 12,001,303.33, BDO: 000034717 (Organizer).
2. The Promotion will last from 12.08.2024 g. 10:00 (GMT +2) until 16.08.2024 g. 23:59 (GMT +2 Central European time) (hereinafter: Promotion Duration).

1. General Provisions

1. The Promotion shall be held in accordance with these Terms and Conditions.
2. Before entering the Promotion, the Participant should read the Terms and Conditions, in particular the terms and conditions of participation in the Promotion.
3. By entering the Promotion, the Participant confirms that he/she has read the Terms and Conditions, understands its provisions and accepts all the rules of the Promotion contained in the Terms and Conditions.

1. Participation in the Promotion

The Promotion may be participated in by a consumer, i.e. a natural person making a legal action under the terms of these Terms and Conditions, not directly related to his/her business or professional activity, as well as an entrepreneur conducting a business or professional activity on his/her own behalf.

1. Terms and conditions of the Promotion

1. The Participant takes part in the Promotion by placing an order at the Organizer's online store at: indigo-nails.com during the Promotion period.
2. The Promotion applies to orders placed during the Promotion without territorial restrictions, subject to the territorial terms of delivery applicable to the Organizer.
3. The Promotion is based on the fact that during the Promotion, the Participant may purchase the Pedicure Base product at a 30% discount, i.e. at the final amount of PLN 29.40. The Promotion accrues in the shopping cart after entering the code PEDI30. Whereas:
 1. **The promotion is valid from 12.08.2024 only** for those who commented on the Organizer's post on Instagram added on 12.08.2024 at the following link: <https://www.instagram.com/p/C-kLSXwofy6/> answering the question *"What do you like Pedicure Base for?"*. In addition, to be eligible for the promotion, the Participant must also indicate the name of the Pedicure Base product in the added comment. Then, in turn, the Participant will receive an automatic private message from the Organizer with a code (the code is PEDI30);
 2. **The Promotion is valid from 13.08.2024 for all persons.**
4. Joining the Promotion is voluntary.
5. During the Promotion, each Participant may place any number of orders.

1. Withdrawal from the sales contract

In the event that the provisions of generally applicable law grant the Participant the right to withdraw from the sales contract and return the products, the return of products purchased in the Promotion is possible insofar as it represents the entire set of new and unused items purchased in the Promotion.

1. Complaints

1. All complaints regarding the way the Promotion is carried out, Participants should submit by email to the Organizer.
2. Complaints will be submitted to: reklamacje@indigo-nails.com
3. Complaints should include a note: "24h Promotion on Builder Color Gels".
4. Complaints can be submitted throughout the duration of the Promotion, and up to 14 days from the date of release of the products that are the subject of the sales agreement concluded under the Promotion.

5. The complaint should contain the following data of the complainant: name, surname and exact address, as well as the exact description and reason for the complaint, as well as the claim of the complainant.
6. Complaints submitted after the deadline or not containing the information referred to in paragraph 5 will not be considered.
7. Complaints will be considered immediately, but no later than within 30 days from the date of their receipt by the Organizer.

1. Protection of personal data

1. The Administrator of the personal data of the Promotion Participants is the Organizer.
2. Personal data collected in connection with the Promotion shall be processed for the purpose of executing the Sales Agreement, for accounting purposes, as well as for the investigation of claims and defense against claims arising from the Sales Agreement - based on the legitimate legal interest of the Administrator, which is the investigation of claims and defense against claims.
3. Participants' personal data may be disclosed to entities supporting the Organizer in the implementation of the Promotion, including in particular marketing agencies, courier companies, Postal Operator, law firm, accounting office.
4. In connection with the processing of personal data by the Organizer, Participants are entitled to the following rights:
 1. The right to access the data and the right to request rectification, deletion or restriction of data processing;
 2. The right to transfer the provided personal data to another administrator;
 3. The right to object to the processing of the data.
5. Participants also have the right to file a complaint with the President of the Office for Personal Data Protection.
6. The personal data of the Promotion Participants will be kept for the period during which it will be possible to make complaints, and in the case of complaints - for the time necessary to process the complaint, until the statute of limitations for claims.
7. Providing personal data is voluntary, however, it is a prerequisite for the execution of the sales contract. Therefore, the consequence of not providing personal data will be the inability to implement the sales contract.

1. Final provisions

1. These Terms and Conditions are available throughout the Promotion on the website: indigo-nails.com.
2. The Terms and Conditions become effective on the date the Promotion begins.
3. During the period of the Promotion the lead time may be extended.
4. Participant, by taking part in the Promotion, accepts their rules contained in these Terms and Conditions and declares that he/she has familiarized

himself/herself with its rules, set forth in the Terms and Conditions, and does not raise any objections in this regard.

5. The Organizer reserves the right to change these Terms and Conditions during the Promotion, without giving any reason, with the proviso that the rights acquired by the Participants before the change will be respected. In particular, the Organizer reserves the right to shorten the duration of the Promotion or to exclude particular items from the Promotion as a result of running out of stock. Such decision may be made separately by the Organizer.
