### REGULATIONS of the "Stylist's Day" EVENT

### **General information**

- 1. The organizer of the "Stylist's Day" event (hereinafter referred to as the "Event") is INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Łódź, ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Economic Division of the National Court Register under KRS number: 0000919132, holding NIP: 7272792881 and REGON: 101805889, (hereinafter referred to as: Indigo Nails).
- 2. Participation in the Event means at the same time that the Participant accepts the present Regulations.
- 3. The Event shall take place in accordance with these Terms and Conditions.

## **Subject of the Rules and Regulations**

- 1. These Terms and Conditions define the conditions of participation in the Event.
- 2. If nothing else follows from these Terms and Conditions, they shall be binding upon all participants of the Event, i.e. persons who register for the Event (hereinafter referred to as Participants).
- 3. The Event may not be attended by persons close to the employees or collaborators of the Organiser, which shall be understood as ascendants, descendants, siblings, spouses, parents and siblings of parents, persons in an adoption relationship, as well as persons under guardianship or curatorship. The Participant of the Event may also not be employees or associates of the Organiser.
- 4. In case of doubt, the Participant shall be any person who has expressed the will to enter the Facility where the Event takes place, i.e. the Organiser's registered office Łódź, 14/16 Senatorska Street, 93-192 Łódź (hereinafter: the Facility).
- 5. Only a person of full legal age may be a participant, unless the Organiser gives individual consent for other persons to participate as well.

### **Registration and participation in the Event**

- 1. The condition for participation in the Event is presentation of a valid ticket with a QR code to a person authorized by the Organizer (each Event Participant is required to have a ticket that he/she has previously purchased through the Organizer's website, i.e. www.indigo-nails.com.
- 2. The Organizer stipulates that the number of people participating in the Event is limited, i.e. in the stationary form the Event may be attended by up to 220 people (in words: two hundred and twenty).

# Rights and obligations of the Organiser and Participants

- 1. Unless otherwise stipulated in the terms and conditions of participation in the Event, the Organiser shall provide the Participant with access to the relevant parts of the facility where the Event takes place.
- 2. Due to the need to ensure the safety, comfort and possibility of verification of Participants, the Organiser identifies them by the code on their ticket.
- 3. The course of the Event shall be recorded photographically and by means of audio/video devices, and it may also be transmitted by other means allowing it to be made available to the

- public in such a way that everyone can have access to it at a place and time of their own choosing (e.g. via the Internet).
- 4. Participation in the Event is public, and therefore the silhouette or image of the Participant, taken individually or as part of a larger whole, may be intentionally or accidentally documented by photographic, audio or video means, and the materials obtained in this manner may be disseminated (without time and territorial restrictions) by the Organiser for information and promotional purposes related to the Event and the Organiser's activity. Notwithstanding the above, the course of the Event may also be monitored for security reasons. The Organiser acknowledges that the Participant taking part in the Event accepts the possibility of the above mentioned recording and use of his/her silhouette or image as a participant in the Event. By purchasing a ticket for participation in the Event, the Participant agrees to this and accepts the content of these Rules and Regulations.

### Rules of order

- 1. Participants may move around the Venue only within the publicly accessible and marked spaces and passageways, in accordance with the Organiser's instructions.
- 2. The following are forbidden in the Event Venue: smoking, use of electronic cigarettes, blocking passageways and evacuation routes, use of open flames and gas cylinders, use of makeshift electrical installations, bringing chemical substances into the exhibition area, blocking access to fire-fighting equipment and evacuation routes. The conditions and location of places where smoking or other of the above-mentioned behaviours may be permitted are decided solely by the Organiser.
- 3. It is forbidden to bring weapons, pyrotechnics and other dangerous materials into the Venue, including those that could lead to fire, damage to property or harm the health of the Participant or others. This also applies to equipment and materials associated with assemblies, adaptations or dismantling that may involve the use of high temperatures or flammable chemicals.
- 4. The Organiser is not responsible for the security of persons and property and therefore for accidents to persons, theft or damage to property at the Venue.
- 5. The Organiser is entitled to refuse entry to the Venue or to remove from the Venue a person who is intoxicated or under the influence of other drugs, as well as any person whose behaviour involves aggression, breach of the rules of social co-existence, risk to personal property, health, order or public morality. In the aforementioned cases, the Organiser is entitled to report the case in question to the security services or law enforcement authorities.
- 6. The Organiser shall not be liable for any damage to Participants resulting from a person not being allowed in or being removed from the Facility where the Event takes place.

#### The course of the event

- 1. The Event consists of a lecture about Indigo brand salons, nail styling show, business training on running a business in the beauty industry, other attractions such as: DJ, massages by Indigo Beauty Center stylists.
- 2. The event will take place at the Organiser's seat, i.e. Lodz, 14/16 Senatorska Street, 93-192 Lodz, Poland and in stationary form.
- 3. The Event will take place on 14.06.2024 at: 15:00-20:00.
- 4. During the Event there will be a demonstration and business training on running a beauty business and a nail styling demonstration conducted by Indigo Instructors.
- 5. Each Event Participant will receive a ticket with randomly assigned discounts. Each discount will be marked with a unique QR code. In order to take advantage of the discount, it will be

- necessary to technically unveil the discount (tear off the card obscuring the discount) and present it to the Showroom staff.
- 6. At the same time, the Organizer stipulates that some of the discounts on the tickets will be placed once, while others will be doubled.
- 7. If it is the intention of the Event Participant to take advantage of the promotion during the Event, he/she will be required to show his/her ticket in advance, or if showing the ticket is not possible then the Participant will be required to provide the email address that was provided by the Participant in the order.

The following products are covered by the promotion:

- 2+1 on hybrid varnishes when you buy two or more hybrid varnishes, you get one free - 2 tickets
- o 33% on hybrid varnishes, with a maximum of 3 hybrid varnishes 1 ticket
- 4+2 on hybrid varnishes when you buy four or more hybrid varnishes, you get two free - 2 tickets
- 3+1 on all bases and tops when you buy three or more hybrid bases and tops, you get one free 2 tickets
- 25% on all bases and tops, with a maximum of four pieces a maximum of 4 pieces -1 ticket
- 6+2 on bases and tops when purchasing six or more bases and tops, you get two free - 1 ticket
- When purchasing four or more creams and lotions, get one free 2 tickets
- 20% discount on 5 pieces of creams/ lotions discount applies to up to five creams/ lotions - 2 tickets
- 2+2 on nail ornaments when you buy two pieces of ornaments, you get two free.
  Promotion applies to ornaments under 15 PLN 2 tickets
- -50% on nail ornaments promotion applies to ornaments in the amount below 15
  PLN 2 tickets.
- 3+1 on all gels when buying three or more gel packs, you will get one free 2 tickets
- o 30% on all gels, with a maximum of four pieces 2 tickets
- 1+1 (buy one product and get another one of the same kind for free) product included in the Hedonista brand offer.
- 8. Endnotes such as, for example, "1 ticket" or "2 tickets" placed at the end of the provisions in items 1-13 in paragraph 8 mean the number of a particular promotion that will be on an A4 sheet of paper, which will contain all the promotions that a participant can use. In this case, there will be two tickets with the same promotion (2+1) on one A4 sheet.
- 9. With the exception of the promotions mentioned above, the Organizer provides promotions for people who have used all the promotions to which they are entitled during the Event, and their intention is, regardless of the promotions received, to continue shopping in the Organizer's Showroom. Then, the Participant, in order to receive additional tickets with discounts, will be required to record and successively share a report (inatstories or reels) from the Event on the Participant's profile maintained on the social network Instagram, in which the Participant will show the recipients the course of the Event, in particular: attractions, shows, while tagging the Organizer, i.e. @indigonails. @indigonails.).
- 10. Each Event Participant will receive a printed certificate of participation in the Event from the Organizer.

- 11. Each Participant of the Event will be able to complete purchases in the Showroom from 15:00-21:00 during the Event.
- 12. The Organizer will provide Participants during the Event with, among others, prosecco, cold snacks (sweet and salty) and drinks cold and hot (coffee, tea).

### Final provisions and complaints

- 1. The Organiser has the right to change the date and place of the Event, and the Participant, will be notified of this by: sending a message in the form of an e-mail, no later than 24 hours before the commencement of the Event. Making such changes shall not result in any additional obligations on the part of the Organiser towards the Participant or any claims of the Participant towards the Organiser. These changes may result, among other things, from changing weather conditions.
- 2. Any complaints related to the exercise of Participants' rights connected with participation in the Event may be reported to the Organiser in writing or by e-mail to reklamacje@indigo-nails.com within 3 days after the end of the Event at the latest, however no later than 3 days from the occurrence of the circumstance giving rise to the complaint.
- 3. In matters not regulated by these Regulations, the provisions of Polish law, in particular of the Civil Code, shall apply.
