RULES OF CONTRACT "Indigo Review Club - Kate Zett's Frees" (hereinafter referred to as the "Rules").

I. Organizer

The organizer of the competition "Indigo Review Club - Kate Zett's Cutters" (hereinafter referred to as the "Competition") is INDIGO NAILS spółka z ograniczoną odpowiedzialnością with its registered office in Łódź, ul. Senatorska 14/16, 93-192 Łódź, entered into the Register of Entrepreneurs by the District Court for Łódź-Śródmieście in Łódź, XX Economic Division of the National Court Register under KRS no.: 0000919132, holding NIP: 7272792881 and REGON: 101805889, share capital: PLN 12,001,303.33, BDO: 000034717 (hereinafter: Organiser).

II. General provisions

- 1. The competition takes place on Instagram.
- 2. The Contest is not a game of chance, lottery, pari-mutuel betting, promotional lottery, game whose result depends on chance, or any other form of game provided for in the Act of 19 November 2009 on Gambling.
- 3. The Competition will be held in accordance with these Terms and Conditions.
- 4. Before entering the Competition, the Participant should read the Rules.
- 5. By entering the Competition, the Participant confirms that he/she has read the Rules, understands their provisions and accepts all the rules of the Competition contained in the Rules.

III. Conditions of participation

- 1. The Competition is open to natural persons (hereinafter referred to as "Participant" or "Participants") meeting the following conditions:
 - have full legal capacity and, in the case of persons with limited legal capacity, the consent of their statutory representative to participate in the Competition;
 - have a public account on Instagram;
- 2. Employees of the Organiser, including those employed on the basis of civil law contracts, and other possible entities directly involved in the preparation and conduct of the Competition, as well as members of their immediate families, cannot participate in the Competition. Members of the immediate family are understood as: ascendants, descendants, persons in an adoption relationship, siblings, spouses, spouses of siblings, relatives and relations by affinity.
- 3. The Competition is not open to distributors, sub-distributors of the Organiser, wholesalers, as well as persons who exhibit products in the market place the above also applies to persons who perform a representative function in the aforementioned entities (i.e. members of the management board, proxies, partners representing the company), as well as partners in the aforementioned entities. This exclusion does not apply to entities which do not sell cosmetic products professionally, and sell individually or occasionally.
- 4. In the event that any of the persons referred to in point 2 or 3 takes part in the Competition and has acquired the right to the Prize, the Organiser shall have the right:

- a. If the Prize has not been dispatched to deprive the participant of the right to the Prize due to failure to meet the conditions of participation in the Competition, which will entail the Prize not being dispatched;
- b. If the Prize has been dispatched, to deprive the participant of their right to the Prize due to a failure to comply with the conditions of participation in the Competition, with the consequence of claiming a return of the Prize in kind or claiming a refund of the value of the Prize - depending on the Organizer's decision:

In addition, in any of these cases, the Organizer may claim from the participant a reimbursement of logistical costs (verification of eligibility to participate in the Contest, processing of the Contest with the participant) related to the execution of the Contest in the amount of EUR 3.20 per each item comprising the Prize.

IV. Rules of participation in the Competition

- 1. To participate in the Competition you must:
 - Purchase a set of cutters by Kate Zett;
 - Record a review (video, reels, other form of recording) with the topic "How do my new cutters (Kate Zett) differ from the ones I had before".
 - Publish the review on the Participant's profile on Instagram with the account tag @indigonails and the hashtags #indigoreviewclub , #indigoreviewclubfrezy
- 2. The Competition runs from 25 May to 25 June 2024.
- 3. You can enter the Competition multiple times, each review is taken into account.

V. Prize in the Competition

- 1. The settlement of the Competition will take place within two weeks after the end of the Competition.
- 2. The settlement will be announced by the Organiser on Instagram. The Organiser will contact the Winners in the form of a private message on Instagram.
- 3. The criteria for the award of the Prize are creativity, content, aesthetics.
- 4. The number of Laureates is not limited. Any Participant who, in the opinion of the Organiser, meets the criteria referred to in paragraph 3, may become a Winner.
- 5. The prizes in the Contest are: discount of 360 PLN (the value of the cutters) to be used in the Indigo Nails online shop http://www.indigo-nails.com/ (with the purchase of at least 361 PLN) and the invitation to the Indigo Reviewers Group.
- 6. The discount code will be communicated to the Winner in the form of a private message on Instagram.
- 7. The Indigo Reviewers Group is a small group of people who review products brilliantly (they provide key information and it is aesthetically pleasing to the eye), who will be given the opportunity to receive a refund of the value of the reviewed product in the form of a discount code the premise of how the Group works is that Indigo reports the need to review a given product, the people in the Reviewers Group purchase the product, and after recording and publishing the review, they receive a discount code of the value of the purchased product.
- 8. The Winner may not request the Prize to be exchanged for a monetary equivalent or any other form of compensation, nor may they transfer the right to the Prize to a third party
- 9. The Winner may waive the right to the Prize.

10. The Organiser has the right to exclude from participation in the Contest and deprive of the right to the Prize Participants who take part in the Contest despite not fulfilling the conditions of participation, Participants who violate these Regulations, as well as Participants who act contrary to the law or good manners, especially when the Contest Work (recording, photo, The Contest Work (recording, photo, description under the Contest Work) contains content that is commonly regarded as offensive, violating or suggesting a violation of the law, morality or good manners, the dignity or rights of third parties, including, in particular, elements related to violence, discrimination, nudity, drugs, alcohol or tobacco, religious sentiments or that otherwise violate the applicable laws or the Rules of Procedure.

VI. Complaints

- 1. All complaints concerning the way the Contest was conducted and the transfer of the Prizes should be submitted by the Participants by e-mail to reklamacje@indigo-nails.com or by post to the Organizer's registered office address given in point I of the Regulations, with the annotation: "Indigo Review Club Kate Zett's Frees"- complaint, in the case of Participants of the Competition within 7 days from the date of announcement of the results of the Competition; in the case of Winners within 7 days from the date of receipt of the Prize.
- 2. The complaint should contain the following data of the person submitting the complaint: first name, surname and the exact address, as well as the exact description and reason for the complaint and the claim of the person submitting the complaint.
- 3. Complaints submitted after the deadline or not containing the information referred to in paragraph 2 shall not be considered. The following shall be deemed the date of sending the complaint: a) in the case of complaints made in writing - the date of the postmark on the parcel containing the complaint; b) in the case of complaints made in the form of an e-mail - the date on which the Organiser confirmed receipt of the complaint.
- 4. Complaints will be considered immediately, however no later than within 30 days of their receipt by the Organiser.

VII. Personal data protection

- 1. The Administrator of the personal data of the Contest Entrants is the Organiser.
- 2. Personal data collected in connection with the Competition will be processed in order to execute the Competition and issue the Prize. The data is processed on the basis of the Participants' consent to participate in the Competition - which is done by taking part in the Competition, as well as for tax purposes and for the purpose of pursuing claims or defending against claims, which constitutes a legitimate legal interest of the Organiser (art. 6 par. 1 pt. a, c, f RODO).
- 3. Participants' personal data may be disclosed to entities supporting the co-administrators in the execution of the Competition, including in particular marketing agencies, courier companies, the Polish Post Office, a law firm, an accounting office.
- 4. In relation to the processing of personal data by the Organiser, Participants have the following rights: a) the right to access the data and the right to request their rectification, erasure or restriction of data processing. b) the right to transfer the

- provided personal data to another administrator. c) the right to withdraw consent to data processing. d) the right to object to data processing;
- 5. Participants also have the right to lodge a complaint with the President of the Office for Personal Data Protection.
- 6. The personal data of the Contest Participants will be stored for the period of limitation of claims.
- 7. Providing personal data for the execution of the Competition, is voluntary. However, providing this data is a necessary condition for participation in the Competition, including in particular the transfer of the Prize. The consequence of failing to provide personal data is the inability to receive the Prize from the Organiser.
- 8. Personal data will not be transferred outside the EEA.
- 9. Personal data will not be subject to profiling.

VIII. Final provisions

- 1. These Rules are available throughout the duration of the Competition on the website www.indigo-nails.com.
- 2. The Rules of Procedure enter into force on the day the Contest begins.
- 3. The Organiser may change the Rules of the Contest at any time, of which it will inform Participants via the Instagram platform. In the case of changes to the Rules, these changes will not affect the rights already acquired by the Participants.
- 4. The Terms and Conditions as amended shall be effective from the moment of publication.
