1. Organiser and duration

- 1. The organiser of the 'Codes for Designers' promotion (hereinafter referred to as the 'Promotion') is Indigo Nails spółka z ograniczoną odpowiedzialnością with its registered office in Łódź (93-192) at Senatorska 14/16, entered into the Register of Entrepreneurs of the National Court Register under KRS number 0000919132, registration court: District Court for Łódź Śródmieście in Łódź, XX Economic Division of the National Court Register, holding REGON number 101805889, NIP number 7272792881 (hereinafter referred to as Indigo Nails).
- 2. The Promotion shall run from 1 September 2024 at 00:01 (GMT +1) until 31 October 2024 at 23:59. or when the stocks are exhausted or the Promotion is cancelled by the Organiser (hereinafter: Promotion duration).

1. Terms and conditions of the Promotion

- 1. 1. Complaints and Returns

- 1. All complaints regarding the way the Promotion is carried out shall be submitted by the Par0cipants by email to reklamacje@indigo-nails.com or by post to the address of Indigo Nails registered office given in point. I sec. 1 of the Regulations, with the subject line: 'AGA Code Complaint' throughout the duration of the Promotion, however no later than 14 days from the date of delivery of the order covered by the Promotion.
- 2. The complaint shall contain the following details of the Participant: first name, surname and exact address, as well as a detailed description and reason for the complaint and the Participant's request.
- 3. Complaints submitted after the deadline or not containing the information referred to in item 2 shall not be examined.
- 4. The date of sending the complaint shall be deemed to be:
 - 1. for complaints sent by post the date of the postmark on the parcel containing the complaint;
 - 2. in the case of complaints sent by e-mail the date of confirmation of receipt of e-mail by the Organiser.

- 6. 1. Protection of personal data
